

### Speakers

#### Dr. David Delmonico

Dr. Delmonico is a Professor at Duquesne University in Pittsburgh, Pennsylvania. Dr. Delmonico is a graduate of Kent State University's Counseling and Human Development Services Program. He conducts research, consultation, and training on topics such as cybersex and cyberoffense. Dr. Delmonico lectures on topics such as Internet psychology, healthy sexuality, and compulsive/hypersexual behavior. He is coauthor of four books including Illegal Images, In the Shadows of the Net, Cybersex Unhooked, and Cybersex Unplugged. He has published numerous journal articles on a variety of technology and sexuality topics. Dr. Delmonico is the founder and director of the Online Behavior Research and Education Center (OBREC) at Duquesne University, co-director of Internet Behavior Consulting, LLC, and past Editor-in-Chief of the Sexual Addiction & Compulsivity journal.

#### **Elizabeth Griffin**

Elizabeth is a licensed Marriage and Family Therapist with nearly thirty years of experience treating individuals with sexually problematic behaviors, especially those that involve the Internet. She has worked in out-patient, in-patient, military, and prison settings. Ms. Griffin lectures nationally on the assessment and treatment of sexual offenders and those with sexually compulsive behavior, as well as issues related to cybersex. She is currently a consultant for the Minnesota Civil Commitment Program She has written numerous professional articles on these topics, and is co-author of four books - In the Shadows of the Net, Cybersex Unhooked, Cybersex Unplugged, and Illegal Images. Ms. Griffin is the founder of Internet Behavior Consulting, a company focused on issues related to problematic online behavior, and sole owner of Griffin Counseling and Consulting, LLC.

### **Christopher Campbell**

Chris has been in law enforcement since 2005 and has investigated cold cases, sexual assaults, homicides, and other significant crimes. In 2010, Chris joined the North Carolina State Bureau of Investigation (NCSBI) and has been a polygraph operator since 2012, conducting criminal and pre-employment testing while working criminal cases.
